RESOLUTION NO. 1939-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH A.T. MACROHON CONSTRUCTION COMPANY FOR THE IMPROVEMENT OF FOOTPATHS AT SITIO SAK-SAK, PUROK CENTER 1, BARANGAY NAALAD, CITY OF NAGA, CEBU IN THE AMOUNT OF NINETY-EIGHT THOUSAND SIX HUNDRED SIXTY PESOS AND 64/100 (₱98,660.64)

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) official website the Request for Quotation for the project: "Supply of labor, materials and equipment for the improvement of existing footpaths (0.35m x 0.70m x 0.10m thk) - 140 pieces at Sitio Sak-sak, Purok Center 1, Barangay Naalad, City of Naga, Cebu;"

WHEREAS, in the Abstract of Quotation dated February 24, 2025, A.T. Macrohon Construction Company, represented by its authorized representative Mr. Albert T. Macrohon, has submitted its bid price in the amount of ₱98,660.64 and was found to be the single calculated and responsive price quotation for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and A.T. Macrohon Construction Company, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government, a Contract of Agreement with A.T. Macrohon Construction Company for the improvement of existing footpath at Sitio Sak-sak, Purok Center 1, Barangay Naalad, City of Naga, Cebu in the amount of Ninety-Eight Thousand Six Hundred Sixty Pesos and 64/100 (₱98,660.64).
