**RESOLUTION NO. 1944-2025**

**AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH A.T. MACROHON CONSTRUCTION COMPANY FOR THE PROPOSED DRAINAGE SYSTEM AT PUROK 15, BARANGAY PANGDAN, CITY OF NAGA, CEBU IN THE AMOUNT OF FIVE HUNDRED TWENTY-EIGHT THOUSAND FOUR HUNDRED THIRTY-FOUR PESOS AND 30/100 (P528,434.30)**

**WHEREAS**, the City Government, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) an Invitation to Bid to PhilGEPS-registered contractors and bidders for the project: *"Supply of labor, materials and equipment for the proposed drainage system at Purok 15, Barangay Pangdan, City of Naga, Cebu;"*

**WHEREAS**, A.T. Macrohon Construction Company, represented by its authorized representative Mr. Albert T. Macrohon, has submitted its bid price in the amount of P528,434.30 and was found to be the single calculated and responsive price quotation for this project;

**WHEREAS**, there is a need to execute a contract by and between the City Government of Naga, Cebu and A.T. Macrohon Construction Company, so as to ensure proper implementation of the project as contained in the approved program of works.




