RESOLUTION NO. 1946-2025

GRANTING MR. REYNALDO O. CABURNAY A SPECIAL PERMIT TO CONDUCT HACKFIGHTS ON MARCH 17, 24 AND 31, 2025 AT NAGA SPORTS ARENA IN BARANGAY SOUTH POBLACION, CITY OF NAGA, CEBU PURSUANT TO CITY ORDINANCE NO. 2024-41 AS AMENDED

WHEREAS, City Ordinance No. 2024-41, as amended governs the establishment, operation and maintenance of cockpits and regulates cockfighting and imposes fees in the City of Naga, Cebu;

WHEREAS, Section 4 (a) of the Ordinance explicitly provides that regular cockfighting shall be held only on Sundays, legal holidays and local fiestas for not more than three (3) days, and requires franchisees to secure permits for the conduct of cockfights to be held not on the aforecited regular schedule;

WHEREAS, Section 4 (b) of the same Ordinance empowers the City Mayor to issue special permits for special cockfights, except on the regular cockfight schedule, valid only for two (2) consecutive days and duly approved by the Sangguniang Panglungsod;

WHEREAS, Mr. Reynaldo O. Caburnay, a franchisee operating the Naga Sports Arena in Barangay South Poblacion, City of Naga, Cebu formally requested in a letter dated March 03, 2025 to the Office of the City Mayor that he be granted a special permit to hold hackfights on the March 17, 24, and 31.

WHEREAS, finding Mr. Caburnay's application in accordance with Ordinance No. 2024-41, this Body deemed it justifiable to grant a special permit to conduct hackfights on the aforementioned place and dates.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Aurelio B. Alinsonorin for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to grant Mr. Reynaldo O. Caburnay a special permit to conduct hackfights on March 17, 24, and 31 at Naga Sports Arena in Barangay South Poblacion, City of Naga, Cebu pursuant to City Ordinance No. 2024-41 as amended.
