**WHEREAS**, Mr. Pablo Garcia III, President and Chief Executive Officer of Power Pro Gas Corporation, has formally expressed his intent to operate an LPG refilling plant as part of the company's expansion in the City of Naga, Cebu;

**WHEREAS**, the Power Pro Gas Corporation, with business address at Tower 2, 9F Oakridge Business Park, Mandaue City, Cebu, identified an area in Barangay Pangdan as the suitable site for the project;

**WHEREAS**, the Office of the City Mayor formally endorsed to this Sanggunian the company's request and evaluate whether it is justifiable to pass a resolution interposing no objection to the establishment of an LPG refilling plant in Barangay Pangdan;




