APPROVING THE PURCHASE OF FAMILY PLANNING FORM ONE (1) CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF FOURTEEN THOUSAND THREE HUNDRED THIRTY PESOS (P14,330.00)

Lianzon, City Population Officer – Designate, for the passage of a resolution approving the use of funds to purchase one thousand (1,000) pieces Family Planning Form one (1) to be used as part of the city's comprehensive family planning program;
