**RESOLUTION NO. 1954-2025**

**AUTHORIZING MS. ELINE E. LAPUT TO TRANSACT WITH APPROPRIATE AGENCIES, FOR AND IN BEHALF OF THE CITY GOVERNMENT, FOR THE TRANSFER OF A PARCEL OF LAND WITH AN AREA OF ONE THOUSAND FIVE HUNDRED TWENTY-EIGHT (1,528) SQUARE METERS (SQ.M.) LOCATED IN BARANGAY COLON, CITY OF NAGA, CEBU IN THE NAME OF THIS LOCAL GOVERNMENT UNIT (LGU)**

**WHEREAS**, on February 12, 2025, the City Council passed Resolution No.1873-2025 authorizing the Honorable City Mayor Valdemar M. Chiong to sign the Deed of Absolute for the acquisition of a 1,528 sq.m. under the name Spouses Armando C. Bansil and Josefina L. Bansil to be used as the site of a new multi-purpose building/evacuation center in Barangay Colon, City of Naga, Cebu;

**WHEREAS**, for and in consideration of Eight Million Five Hundred Thousand Pesos (P8,500,000.00) as purchase price, the City Government acquired the subject property covered by Transfer Certificate of Title (TCT) No. 102-2024000069 and identified as Lot 890-Part of Survey No. Lot 4-A of approved Plan No. PSD-07-118142;

**WHEREAS**, the City Government has to engage the services of Ms. Eline E. Laput to transact with concerned government agencies in order to expedite and formalize the transfer of the subject lot from Spouses Bansil to this LGU.

**NOW THEREFORE**, on motion of Hon. Carmelino N. Cruz, Jr., seconded by Hon. Clint Isidro A. Chiong, for the approval of the resolution, be it

**RESOLVED**, as it is hereby **RESOLVED**, to authorize Ms. Eline E. Laput to transact with appropriate agencies, for and in behalf of the City Government, for the transfer of a parcel of land with an area of 1,528 sq.m. located in Barangay Colon, City of Naga, Cebu.
