## **RESOLUTION NO. 1959-2025**

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A CONTRACT OF AGREEMENT WITH A.T. MACROHON CONSTRUCTION COMPANY FOR THE PROPOSED BARANGAY ROAD CONCRETING AT PUROK 3 MANGGA, BARANGAY BAIRAN, CITY OF NAGA, CEBU IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED EIGHTEEN THOUSAND THREE HUNDRED SEVENTY-THREE PESOS AND 73/100 (₱1,818,373.73)

WHEREAS, the City Government of Naga, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) official website an Invitation to Bid to PhilGEPS-registered contractors and bidders for the project: "Supply of labor, materials and equipment for the proposed barangay road concreting at Purok 3 Mangga, Barangay Bairan, City of Naga, Cebu;"

WHEREAS, A.T. Macrohon Construction Company, represented by its authorized representative Mr. Albert T. Macrohon, has submitted its bid price in the amount of ₱1,818,373.73 and was found to be the single calculated and responsive price quotation for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and A.T. Macrohon Construction Company, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Contract of Agreement with A.T. Macrohon Construction Company for the proposed barangay road concreting at Purok 3 Mangga, Barangay Bairan, City of Naga, Cebu in the amount of One Million Eight Hundred Eighteen Thousand Three Hundred Seventy-Three Pesos and 73/100 (₱1,818,373.73).
