RESOLUTION NO. 1965-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO ENTER INTO, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH FIRST GRANDEUR BUILDERS FOR THE PROPOSED SITE DEVELOPMENT FOR MULTI-PURPOSE BUILDING IN BARANGAY NAALAD, CITY OF NAGA, CEBU IN THE AMOUNT OF TWO MILLION SIX HUNDRED SIXTY-EIGHT THOUSAND TWENTY-FOUR PESOS AND 08/100 (\$2,668,024.08)

WHEREAS, in view of the two (2) failed biddings, the City Government entered into Negotiated Procurement through Two Failed Biddings in accordance with Section 53.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" for RFQ No. 2025-INFRA-01 for the project: "Supply of labor, materials and tools for the proposed site development for Multi-Purpose Building in Barangay Naalad, City of Naga, Cebu";

WHEREAS, the First Grandeur Builders has submitted its bid price of ₱2,668,024.08 and was found to be a single calculated and quotation bid for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and First Grandeur Builders, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to enter into, for and in behalf of the City Government, a Contract of Agreement with First Grandeur Builders for the proposed site development for Multi-Purpose Building in Barangay Naalad, City of Naga, Cebu in the amount of Two Million Six Hundred Sixty-Eight Thousand Twenty-Four Pesos and 08/100 (\$\mathbb{P}2,668,024.08).
