## **RESOLUTION NO. 1966-2025**

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO ENTER INTO, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH A.T. MACROHON CONSTRUCTION COMPANY FOR THE PROPOSED INSTALLATION OF SOLAR STREET LIGHTS IN BARANGAY ULING, CITY OF NAGA, CEBU IN THE AMOUNT OF NINE HUNDRED SEVENTY-ONE THOUSAND NINETEEN PESOS AND 28/100 (₱971,019.28)

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), posted on Philippine Government Electronic Procurement System (PhilGEPS) official website an invitation to Bid to PhilGEPS registered contractors and bidders for the project: "Supply of labor, materials and tools for the proposed installation of solar street lights in Barangay Uling, City of Naga, Cebu";

WHEREAS, the A.T. Macrohon Construction Company has submitted its bid price of ₱971,019.28 and was found to be a single calculated and responsive bid for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and A.T. Macrohon Construction Company, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to enter into, for and in behalf of the City Government of Naga, Cebu, a Contract of Agreement with A.T. Macrohon Construction Company for the proposed installation of solar street lights in Barangay Uling, City of Naga, Cebu in the amount of Nine Hundred Seventy-One Thousand Nineteen Pesos and 28/100 (₱971,019.28).
