## **RESOLUTION NO. 1967-2025**

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO ENTER INTO, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH A.T. MACROHON CONSTRUCTION COMPANY FOR THE REHABILITATION OF AN EXISTING CANAL AT PUROK LOWER 2, BARANGAY NAALAD, CITY OF NAGA, CEBU IN THE AMOUNT OF ONE HUNDRED NINETY-FIVE THOUSAND FIVE HUNDRED SEVENTY-FOUR PESOS AND 25/100 (₱195,574.25)

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), posted on Philippine Government Electronic Procurement System (PhilGEPS) official website the request for quotation for the project: "Supply of labor, materials and equipment for the rehabilitation of an existing canal at Purok Lower 2, Barangay Naalad, City of Naga, Cebu";

WHEREAS, in the Abstract of Quotation dated February 24, 2025, A.T. Macrohon Construction Company submitted the lowest calculated and responsive price quotation for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and A.T. Macrohon Construction Company, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to enter into, for and in behalf of the City Government, a Contract of Agreement with A.T. Macrohon Construction Company for the rehabilitation of an existing canal at Purok Lower 2, Barangay Naalad, City of Naga, Cebu in the amount of One Hundred Ninety-Five Thousand Five Hundred Seventy-Four Pesos and 25/100 (₱195,574.25).
