APPROVING THE DEPUTIZATION OF LOCAL SOLID WASTE MANAGEMENT OFFICERS CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF TWO HUNDRED FORTY-FIVE THOUSAND EIGHT HUNDRED FIVE PESOS (\$\frac{1}{2}\$245,805.00)

WHEREAS, the Office of the City Environment and Natural Resources – Solid Waste Management will conduct and facilitate a two-day training and deputization which the target participants are the Barangay Officials, Purok Leaders and City Green Marshals;

WHEREAS, this training will equip these officers with the knowledge and skills needed to implement effective waste management, enforce policies, promote community involvement, and apprehend violators;

WHEREAS, this Sanggunian deemed the request appropriate in order to support the training for effective solid waste management which will take place on April 03 & 04, 2025 at the Enan Chiong Activity Center (ECAC).

RESOLVED, as it is hereby **RESOLVED**, to approve the deputization of Local Solid Waste Management Officers chargeable against lump sum appropriation specifically Gen. Fund 2025 – Environmental Services – Solid Waste Management: Deputize Barangay & City Green Marshals (City Environmental and Natural Resources Office) in the amount of Two Hundred Forty-Five Thousand Eight Hundred Five Pesos (₱245,805.00).
