It will provide effective display of key information, data, and multimedia content, ensuring better understanding of complex topics. Moreover, the LED wall ensures visibility for all attendees, regardless of seating position and supports a professional and impactful seminar experience.

WHEREAS, the City Budget Office has verified the existence of the above-stated appropriation and released allotment under the City Environment and Natural Resources Office;

WHEREAS, this August Body finds it justifiable to grant the request for funding allocation after it ascertained the availability of appropriations and released allotment as contained in the city's approved annual budget.


