RESOLUTION NO. 1975-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, THE DEED OF DONATION AND ACCEPTANCE WITH SPOUSES JOSE C. PARUNGAO AND DECESA L. PARUNGAO RELATIVE TO THE LATTER'S DONATION OF A PARCEL OF LAND FOR THE CONSTRUCTION OF AN ACCESS ROAD IN BARANGAY SOUTH POBLACION, CITY OF NAGA, CEBU

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units (LGUs) shall, among others, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Spouses Jose and Decesa Parungao intend to donate a portion of their property totaling five hundred eighty-nine (589) square meters located in Barangay South Poblacion in favor of the City Government of Naga, Cebu;

WHEREAS, the City Government lauded the generosity of the Parungao spouses as the parcel of land covered with Tax Declaration No. 01-30-001611 and Cadastral Lot No. 467 (lot 2 PSU-0701-002515) will be used for the development and construction of an access road in the area;

WHEREAS, this Sanggunian, in a session duly assembled, recognized the importance of formalizing the signing and execution of the Deed of Donation and Acceptance between this LGU and the Parungao spouses because the access road is seen to provide better accessibility and contribute economic progress to the city.


NOW THEREFORE, on mass motion of all the Sangguniang Panlungsod Members present, duly seconded en masse, for the approval of the Resolution, be it
