RESOLUTION NO. 1978-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH BT CONSTRUCTION AND GENERAL SERVICES FOR THE PROPOSED WATER SYSTEM PHASE 2 IN BARANGAY MAYANA, CITY OF NAGA, CEBU IN THE AMOUNT OF TWO MILLION ONE HUNDRED FIFTY-SEVEN THOUSAND TWO HUNDRED EIGHTY-FIVE PESOS AND 62/100 (₱2,157,285.62)

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) official website an Invitation to Bid to PhilGEPS-registered contractors and bidders for the project: "Supply of labor, materials and equipment for the proposed water system phase 2 in Barangay Mayana, City of Naga, Cebu;"

WHEREAS, BT Construction and General Services, represented by its authorized representative Mr. Benjamin O. Tan, has submitted its bid price in the amount of ₱2,157,285.62 and was found to be the single calculated and responsive price quotation for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and BT Construction and General Services, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government, a Contract of Agreement with BT Construction and General Services for the proposed water system phase 2 in Barangay Mayana, City of Naga, Cebu in the amount of Two Million One Hundred Fifty-Seven Thousand Two Hundred Eighty-Five Pesos and 62/100 (₱2,157,285.62).
