RESOLUTION NO. 1980-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH FIRST GRANDEUR BUILDERS FOR THE PROPOSED CONSTRUCTION OF A THREE (3)-STOREY SIX (6)-CLASSROOM SCHOOL BUILDING AT TAGJAGUIMIT SENIOR HIGH SCHOOL, BARANGAY TAGJAGUIMIT, CITY OF NAGA, CEBU AMOUNTING TO TWENTY-TWO MILLION SEVEN HUNDRED THIRTY-THREE THOUSAND FOUR HUNDRED TEN PESOS AND 99/100 (₱22,733,410.99)

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), posted on Philippine Government Electronic Procurement System (PhilGEPS) official website an invitation to Bid to PhilGEPS registered contractors and bidders for the project: *"Supply of labor, materials and equipment for the proposed construction of a three (3)-Storey six (6)-Classroom School Building at Tagjaguimit Senior High School, Barangay Tagjaguimit, City of Naga, Cebu";*

WHEREAS, the First Grandeur Builders has submitted its bid price of ₱22,733,410.99 and was found to be a single calculated and responsive bid for this project;

WHEREAS, there is a need to execute a contract by and between the City Government and First Grandeur Builders, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government, a Contract of Agreement with First Grandeur Builders for the proposed construction of a three (3)-Storey six (6)-Classroom School Building at Tagjaguimit Senior High School, Barangay Tagjaguimit, City of Naga, Cebu amounting to Twenty-Two Million Seven Hundred Thirty-Three Thousand Four Hundred Ten Pesos and 99/100 (₱22,733,410.99).
