RESOLUTION NO. 1985-2025

APPROVING THE RENT PAYMENT OF A LIGHT-EMITTING DIODE (LED) WALL FOR THE TRAINING AND DEPUTIZATION OF THE LOCAL SOLID WASTE MANAGEMENT OFFICERS CHARGEABLE AGAINST LUMP SUM APPROPRIATION AMOUNTING TO THIRTY THOUSAND PESOS (P30,000.00)

WHEREAS, using a LED wall in the training and deputization of barangay officials, purok leaders, and city green marshals will provide a clear and large visual presentation for audience engagement, comprehension, and visibility for the seminar attendees;

WHEREAS, the Office of the City Environment and Natural Resources requested this Sanggunian for approval of a budget allocation to pay the rent of one (1) unit LED wall to be set up during a two-day training and deputization of local solid waste management officers in the City of Naga, Cebu on April 03 – 04, 2025;

WHEREAS, this August Body, in a session duly assembled, deemed it proper to grant the request for funding allocation so as to support the successful conduct of the training and deputization of the aforementioned officers for effective and efficient implementation of city's Local solid Waste Management programs.


NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it


