WHEREAS, Engr. Nico Anthony F. Tejano, a resident of Barangay Tuyan, City of Naga, Cebu, brought honor and prestige to the city for placing first in the February 2025 Mechanical Engineers Licensure Examination with a rating of 93.50%;
