RESOLUTION NO. 1990-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH CEBU SINAG BUILDERS CORPORATION FOR THE PROPOSED 1-STOREY 3-CLASSROOM SCHOOL BUILDING IN BARANGAY CANTAO-AN, CITY OF NAGA, CEBU IN THE AMOUNT OF SEVEN MILLION SEVEN HUNDRED TWENTY-TWO THOUSAND NINE HUNDRED FIFTEEN PESOS AND 90/100 (₱7,722,915.90)

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) official website an Invitation to Bid to PhilGEPS-registered contractors and bidders for the project: "Supply of labor, materials and equipment for the proposed 1-storey 3-classroom school building in Barangay Cantao-an, City of Naga, Cebu;"

WHEREAS, Cebu Sinag Builders Corporation, represented by its authorized managing officer Mr. Jeson S. Bajarias, has submitted its bid price in the amount of ₱7,722,915.90 and was found to be the single calculated and responsive price quotation for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and Cebu Sinag Builders Corporation, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government, a Contract of Agreement with Cebu Sinag Builders Corporation for the proposed 1-storey 3-classroom school building in Barangay Cantao-an, City of Naga, Cebu in the amount of Seven Million Seven Hundred Twenty-Two Thousand Nine Hundred Fifteen Pesos and 90/100 (₱7,722,915.90).
