## **RESOLUTION NO. 1991-2025**

APPROVING THE COST OF PROJECTS CHARGEABLE AGAINST LUMP SUM APPROPRIATION FOR THE REHABILITATION OF LOOP STRUCTURE DECKING AT PASILONG SA NAGA, BARANGAY EAST POBLACION AND REHABILITATION OF 2-UNITS MOVABLE POLICE OUTPOST IN VARIOUS BARANGAYS IN THE CITY OF NAGA, CEBU IN THE TOTAL AMOUNT OF FIVE MILLION FIVE HUNDRED THIRTY-FIVE THOUSAND PESOS (₱5,535,000.00)

Rehabilitation of two (2)-units movable police outpost, - ₱235,000.00 various barangays, City of Naga, Cebu
