RESOLUTION NO. 1995-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A SUPPLEMENTAL AGREEMENT WITH NEW CEBU NIÑO SECURITY AGENCY FOR THE IMPLEMENTATION OF THE SALARY INCREASE OF THE LATTER'S SECURITY PERSONNEL FROM TWENTY-FIVE THOUSAND FIVE HUNDRED THIRTEEN PESOS AND 89/100 (₱25,513.89) TO TWENTY-SEVEN THOUSAND THREE HUNDRED SEVENTY-EIGHT PESOS AND 65/100 (₱27,378.65) PER SECURITY GUARD PER MONTH PURSUANT TO REGIONAL TRIPARTITE WAGES AND PRODUCTIVITY BOARD (RTWPB) NEW WAGE ORDER NO. ROVII-25

WHEREAS, on February 22, 2024, the City of Naga-Local Government Unit (LGU) executed a multi-year Contract Agreement with New Cebu Niño Security Agency (NCNSA), a duly organized corporation with office address at 489A P. Del Rosario Extension, Sambag I, Cebu City, for the ***"Provision of Security Services for 2024 in the City of Naga, Cebu;"***

WHEREAS, Article IV on Terms of Payment of the Principal Contract provides that NCNSA's bid price shall be fixed for a duration of three (3) years and shall not be adjusted during contract implementation, except for the following:

- "i Increase in minimum daily wage pursuant to law or new wage order issued after date of bidding subject to availability of local funds;*
- ii. xxx*

WHEREAS, on September 27, 2024, NCNSA, through its General Manager McDonald A. Arquiza, informed the City of Naga-LGU that it would implement the salary increase from ₱25,513.89 to ₱27,378.65 per security guard per month pursuant to RTWPB New Wage Order No. ROVII-25 effective October 02, 2024;

WHEREAS, the draft Supplemental Agreement states that the aforementioned salary increase shall be effective until December 2025 to retract on October 2024, upon the effectivity of the Wage Order with the following amounts:

- For the period of January 2025 to December 2025 – an amount of ₱27,378.65 for every security guard per month for ninety-nine (99) personnel
- For the subsequent years, an amount of ₱27,378.65 for every security guard per month for 99 personnel

WHEREAS, the City of Naga-LGU shall pay NCNSA provided that the latter submit a Monthly Deployment Report containing the names of the guards and supervisors, salary rates, an actual attendance at the end of each month including proof of remittance of premiums to Social Security Systems, Philippine Health Insurance Corp. and other concerned government agencies for the benefit of security guards.

NOW THEREFORE, on motion of Hon. Letecia F. Abangan, seconded by Hon. Elmer John R. Lapitan, for the approval of the resolution, be it


RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Supplemental Agreement with New Cebu Niño Security Agency for the implementation of the salary increase of the latter's security personnel from ₱25,513.89 to ₱27,378.65 per security guard per month pursuant to the RTWPB New Wage Order No. ROVII-25.

RESOLVED FURTHER, to furnish copies of this Resolution the Office of the City Mayor, the NCNSA, other concerned City Hall departments and national government agencies for their reference, file and appropriate action.




