**AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF SERVICE WITH MR. ARTHUR A. DASIAN IN HIS CAPACITY AS A TENNIS TRAINER AMOUNTING TO TEN THOUSAND PESOS (P10,000.00) PER MONTH CHARGEABLE AGAINST THE SPECIAL EDUCATION FUND (SEF) 2025 – HONORARIA**

**WHEREAS**, the City Government is need of a qualified trainer to oversee the recruitment, training and coaching of the members of the tennis team of the City of Naga, Cebu;

**WHEREAS**, the Department of Education City of Naga Schools Division (DepEd-City of Naga) passed Resolution No. 037-2025, series of 2025, approving the hiring of Mr. Arthur A. Dasian as a tennis sports trainer for the period March 2025 to December 31, 2025 chargeable against the Special Education Fund (SEF) 2025 – Honoraria;

**WHEREAS**, Mr. Arthur A. Dasian, a resident of Purok Talong 3, South Poblacion, City of Naga, Cebu has the knowledge, necessary skills and experience required by this local government unit and shall conduct the tennis training for the student-athletes in accordance with the timetable, procedures and system approved by the DepEd-City of Naga;

**WHEREAS**, Mr. Dasian shall receive a monthly honorarium of P10,000.00 from the City Government, subject to the usual audit and accounting rules and regulations.






