RESOLUTION NO. 1998-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH ALM MARKETING FOR THE SUPPLY AND DELIVERY OF CLOSED-CIRCUIT TELEVISION (CCTV) CAMERAS INCLUDING INSTALLATION FOR THE CITY OF NAGA PUBLIC MARKET, BARANGAY EAST POBLACION, CITY OF NAGA, CEBU IN THE AMOUNT OF ONE MILLION FIVE HUNDRED EIGHTY-NINE THOUSAND TWO HUNDRED TWENTY-TWO PESOS (₱1,589,222.00)

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) official website an Invitation to Bid to PhilGEPS-registered bidders for the project: "Supply and delivery of Closed-Circuit Television (CCTV) Cameras including installation for the City of Naga Public Market, Barangay East Poblacion, City of Naga, Cebu;

WHEREAS, ALM Marketing, a single proprietorship company with business address at Lopez Jaena St., Barangay Subangdaku, Mandaue City, Cebu and represented by its proprietor, Mr. Luis M. Marikit, has submitted its bid price in the amount of ₱1,589,222.00 and was found to be the lowest calculated bid for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and ALM Marketing, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government, a Contract of Agreement with ALM Marketing for the supply and delivery of CCTV Cameras including installation for the City of Naga Public Market, Barangay East Poblacion, City of Naga, Cebu in the amount of One Million Five Hundred Eighty-Nine Thousand Two Hundred Twenty-Two Pesos (₱1,589,222.00).
