WHEREAS, the Commission on Elections (Comelec), as guardians of the sovereign will of the people, along with the election stakeholders would like to ensure that election servants and poll workers, must be equipped with full grasp of the knowledge and skills to administer the free, honest, orderly, peaceful and credible elections for the May 12, 2025 NLE;
