RESOLUTION NO. 2007-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A MEMORANDUM OF AGREEMENT (MOA) WITH UCPB SAVINGS BANK, INC. FOR THE IMPLEMENTATION OF KASAMA MO SALARY LOAN PROGRAM

WHEREAS, UCPB Savings Bank, Inc., a government-owned and controlled thrift and savings banking institution, in an offer and acceptance basis, is willing to extend salary loans with Mortality Redemption Insurance (MRI) on a payroll deduction basis through its Kasama Mo Salary Loan (KMSL) Program;

WHEREAS, the KMSL Program is a salary loan program offered by UCPB Savings Bank Inc. to eligible individuals, including government employees and private sector workers which will be facilitated through a payroll deduction scheme;

WHEREAS, the City Government of Naga, Cebu has no objection to the availment of its employees of the KMSL Program, subject to the terms and conditions as stated in the MOA and other related documents to be executed therein;

WHEREAS, this Body, in a session duly assembled, found the request justifiable, as it gives the qualified/eligible working city employees the opportunity to avail of the KMSL Program.
