**RESOLUTION NO. 2008-2025**

**AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A MEMORANDUM OF AGREEMENT (MOA) WITH VERTEX ONE APPAREL PHILS. INC. FOR THE LATTER'S RENEWAL OF THE CONDUCT OF SEWING SKILLS TRAINING AT NO COST TO THE LOCAL GOVERNMENT UNIT (LGU)**

**WHEREAS**, Vertex One Apparel Phils. Inc. is a domestic corporation with business address at Lot 8 Block 4, Crescent Road, Cebu Light Industrial Park, Basak, Lapu-lapu City, Cebu engaged in apparel manufacturing for export and requires the services involving work or skills, directly related to its sewing business and operations;

**WHEREAS**, the City Government considers a partnership with Vertex One as the best way to implement its skills training and livelihood program to achieve the goals of providing job opportunities to qualified applicants or trainees;

**WHEREAS**, with its existing training facility to pursue the sewing skills and livelihood training program, the City Government deems it justifiable to formalize its partnership with Vertex One through a MOA;

**WHEREAS**, the proposed one-year MOA will take effect on May 01, 2025 until April 30, 2026, and shall be considered terminated upon its expiration unless renewed or extended upon agreement of the parties.

**NOW THEREFORE**, on motion of Hon. Elmer John R. Lapitan, seconded by Hon. Charmaine R. Navarro, for the approval of the resolution, be it

**RESOLVED**, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a MOA with Vertex One Apparel Phils. Inc. for the latter's renewal of the conduct of sewing skills training at no cost to the LGU.
