## **RESOLUTION NO. 2012-2025**

GRANTING FOUR THOUSAND PESOS (₱4,000.00) MONTHLY HONORARIUM TO POLICE LIEUTENANT (PLT) ALNER LIMPAHAN MAGLINTE IN HIS CAPACITY AS DEPUTY CHIEF OF POLICE FOR OPERATIONS OF THE CITY OF NAGA POLICE STATION EFFECTIVE **JANUARY 31, 2025** 

WHEREAS, Section 458 (1) (xi) of RA 7160 or the Local Government Code of 1991 states that when the finances of the city allow, the City Government "shall provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers, and other national government officials stationed in or assigned to the city;"

WHEREAS, PLT Maglinte assumed the post of the City of Naga, Cebu Police Station as Deputy Chief of Police for Operations;

WHEREAS, the Office of the City Mayor, in its letter dated April 15, 2025, favorably endorsed to this August Body the grant of ₱4,000.00 monthly honorarium to PLT Maglinte, previously accorded to his predecessor, PLT John Paul L. Galacio effective upon his formal assumption of office;

WHEREAS, this Sanggunian, in a session duly assembled, deemed it proper to approve the monthly incentive of PLT Maglinte effective upon his formal assumption on January 31, 2025.

NOW THEREFORE, on motion of Hon. Clint Isidro A. Chiong, seconded by Hon. Carmelino N. Cruz, Jr., for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to grant Four Thousand Pesos (₱4,000.00) monthly honorarium to PLT Alner Limpahan Maglinte in his capacity as Deputy Chief of Police for Operations of the City of Naga Police Station effective January 31, 2025.
