RESOLUTION NO. 2024-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE CONDUCT OF TRANSFER OF FUNDS TO THE LOCAL GOVERNMENT UNIT (LGU) IN THE AMOUNT OF FIVE MILLION FOUR HUNDRED THOUSAND PESOS (₱5,400,000.00) FOR THE IMPLEMENTATION OF THE SUPPLEMENTARY FEEDING PROGRAM CYCLE 15 **CALENDAR YEAR (CY) 2025**

WHEREAS, the Supplementary Feeding Program (SFP) is the provision of food in addition to the regular meals targeting children ages 2-4 years old who are enrolled in the Child Development Center and Supervised Neighborhood Play as part of the DSWD's contribution to the Early Childhood Care and Development Program of the Government;

WHEREAS, under Section 4(a) of RA No. 11037 otherwise known as the "Masustansyang Pagkain Para sa Batang Pilipino," the DSWD, in coordination with the LGUs, is tasked to implement the SFP for undernourished children ages 3-5 years, including the provision of at least one (1) fortified meal for a period of not less than 120 days in a year;

WHEREAS, the LGUs, as partners of the DSWD in delivering programs and projects, shall assist in the implementation of the SFP aimed at addressing the issue of hunger and food security among Filipino children and preventing regression of the current nutritional status of the beneficiaries.

NOW THEREFORE, on motion of Hon. Letecia F. Abangan, seconded by Hon. Carmelino N. Cruz, Jr., for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government, a MOA with the DSWD for the conduct of transfer of funds to the LGU in the amount of Five Million Four Hundred Thousand Pesos (₱5,400,000.00) for the implementation of the Supplementary Feeding Program Cycle 15 Calendar Year (Cy) 2025.
