RESOLUTION NO. 2028-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, THE MEMORANDA OF AGREEMENT (MOA) WITH SCHOOLS/UNIVERSITIES, PARENTS AND SCHOLARS IN RELATION TO THE CITY OF NAGA COLLEGE SCHOLARSHIP PROGRAM

WHEREAS, the City Government recognizes the importance of college education for deserving secondary school graduates especially those who do not have the resources to pursue tertiary education;

WHEREAS, the City of Naga College Scholarship Grant is a scholarship program that supports 150 college students every year and subsidizes the school fees in the amount not exceeding ₱25,000.00 for the first 100 qualified scholars, and ₱10,000.00 for the remaining 50 scholars per semester;

WHEREAS, pursuant to the Sangguniang Panlungsod Ordinance No. 2021-67 dated July 01, 2021, the amount of ₱10,000.00 per semester or ₱20,000.00 per school year subsidy shall be given to scholars as stipend;

WHEREAS, the City Government, in partnership with the Department of Education (DepEd) – City of Naga Schools Division, is currently using the amended implementing rules and guidelines to ensure the success of this scholarship program.

NOW THEREFORE, on motion of Hon. Clint Isidro A. Chiong, seconded by Hon. Carmelino N. Cruz, Jr., for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to enter into and sign, for and in behalf of the City Government of Naga, Cebu, the following MOA enumerated here, viz:
