RESOLUTION NO. 2029-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A TRIPARTITE MEMORANDUM OF AGREEMENT (MOA) WITH VICENTE SOTTO MEMORIAL MEDICAL CENTER – WOMEN AND CHILDREN PROTECTION CENTER (VSMMC-WCPC) AND CHILD PROTECTION NETWORK FOUNDATION, INC. (CPN FOUNDATION) TO FORMALIZE THE INTEGRATED SUPPORT SERVICES FOR ABUSED AND AT-RISK WOMEN AND CHILDREN

WHEREAS, the City Government of Naga, Cebu, as a partner local government unit, is mandated under Article 360 of the Civil Code of the Philippines, Article 87 of Presidential Decree No. 603, and Section 5 of Republic Act 4881, otherwise known as "*An Act Creating a Council for the Protection of Children in every City and Municipality of the Philippines*", to look after the welfare and protection of all children in their cities and municipalities, as it expresses its desire to assist VSMMC WCPC in the fulfillment of the latter's goals;

WHEREAS, the VSMMC WCPC integrates medical diagnostic, forensic, therapeutic and preventive responses to abused women and children in order to (1) provide the necessary healthcare and psychosocial services, (2) minimize – if not prevent – re-traumatization, and (3) support the woman and child and his/her family to stop the abuse and keep the woman and child safe;

WHEREAS, the City Government desires to perform a more proactive role in helping the women and children especially the abused and those at risk, and agrees to partner with VSMMC WCPC by providing a base from which women and children from the different barangays may access the latter's services electronically and digitally and to perform other services;

NOW THEREFORE, on motion of Hon. Charmaine R. Navarro, seconded by Hon. Letecia F. Abangan, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to enter into and sign, for and in behalf of the City Government of Naga, Cebu, a Tripartite MOA with VSMMC-WCPC and CPN Foundation to formalize the integrated support services for abused and at-risk women and children.
