RESOLUTION NO. 2030-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A SUPPLEMENTAL AGREEMENT WITH THE FOUR (4) PHYSICIANS ASSIGNED AT VICENTE MENDIOLA CENTER FOR HEALTH (VMCH)-INFIRMARY

WHEREAS, the VMCH-Infirmary has been operating since 2018 as the city's one-stop health facility to address the health and medical needs of the Nagahanons and the general public;

WHEREAS, subjected to deliberation is the request of Atty. Jessica F. Banzon-Natad, City Legal Officer, for the passage of a resolution authorizing the Honorable City Mayor Valdemar M. Chiong to sign a Supplemental Agreement with the four (4) physicians assigned at the VMCH-Infirmary, enumerated here as follows:

WHEREAS, on December 19, 2024, the Sangguniang Panlungsod, through Resolution No. 1783-2024, approved the renewal of the Contract of Service of medical doctors including the above-named specialists;

WHEREAS, the City Government and the above-named physicians recognized the need to amend Item I of the original contract to indicate the minimum hours of duty per week as reflected in Annex "A" of the contract.

NOW THEREFORE, on motion of Hon. Carmelino N. Cruz, Jr., seconded by Hon. Clint Isidro A. Chiong, for the approval of the resolution, be it
