RESOLUTION NO. 2033-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A MEMORANDUM OF AGREEMENT (MOA) WITH APO CEMENT CORPORATION FOR THE PROVISION AND SUSTAINABILITY OF BASIC HEALTHCARE AND MEDICAL SERVICES OF VICENTE MEDIOLA CENTER FOR HEALTH (VMCH) AMOUNTING TO ONE MILLION TWO HUNDRED THOUSAND PESOS (₱1,200,000.00)

WHEREAS, Republic Act (RA) No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall, among others, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Apo Cement Corporation, a major cement manufacturer and supplier based in Barangay Tina-an, City of Naga, Cebu, recognizes the noble task of the City Government in promoting the basic healthcare services to the Nagahanons:

WHEREAS, the cement manufacturing firm has maintained its commitment to support the city's healthcare programs and medical services, by allotting a portion of its annual Social Development Management Program (SDMP) or Corporate Social Responsibility (CSR) Fund for VMCH:
