RESOLUTION NO. 2034-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A MEMORANDUM OF AGREEMENT (MOA) WITH APO LAND AND QUARRY CORPORATION (ALQC) FOR THE PROVISION AND SUSTAINABILITY OF BASIC HEALTHCARE AND MEDICAL SERVICES OF VICENTE MEDIOLA CENTER FOR HEALTH (VMCH) AMOUNTING TO EIGHT HUNDRED THOUSAND PESOS (₱800,000.00)

WHEREAS, Republic Act (RA) No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall, among others, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, ALQC recognizes the noble task of the City Government in promoting the basic healthcare programs by allotting a portion of its annual Social Development Management Program (SDMP) or Corporate Social Responsibility (CSR) Fund for the sustainability of VMCH medical services to the Nagahanons;

WHEREAS, the August Body, in a session duly assembled, commended ALQC as the financial support taken from its SDMP or CSR fund will ensure the uninterrupted basic healthcare and medical services of VMCH to the public.

NOW THEREFORE, on motion of Hon. Carmelino N. Cruz, Jr., seconded by Hon. Letecia F. Abangan, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a MOA with ALQC for the provision and sustainability of basic healthcare and medical services of VMCH amounting to Eight Hundred Thousand Pesos (₱800,000.00)
