**APPROVING THE ALLOCATION OF FUND FOR THE PROCUREMENT OF ONE (1) UNIT UTILITY VAN AND ONE (1) UNIT PICKUP VEHICLE CHARGEABLE AGAINST TRUST FUND-OFFICE OF BUILDING OFFICIAL (OBO) FUNDS TOTALING TWO MILLION SEVEN HUNDRED FORTY THOUSAND FOUR HUNDRED FIFTY PESOS (P2,740,450.00)**

**WHEREAS**, Republic Act (RA) No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units (LGU) shall, among others, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, subjected to deliberation is the request of the Office of the City Mayor for the allocation of fund for the procurement of one unit utility van and another one unit pickup vehicle for official use of this LGU, with details specified below:
