APPROVING THE SUPPLY AND DELIVERY OF MOVABLE TENTS TO PUROKS OF BARANGAY ULING, CITY OF NAGA, CEBU FOR USE IN VARIOUS BARANGAY ACTIVITIES, COMMUNITY EVENTS, EMERGENCY RESPONSE AND OTHER BARANGAY RELATED OPERATIONS CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF FIVE HUNDRED FIFTY THOUSAND PESOS (₱550,000.00)

WHEREAS, the Office of the City General Services Officer has requested this Sanggunian for the passage of a resolution approving the use of funds to provide twenty-two (22) units heavy duty movable tents to be distributed to the twenty-two (22) puroks of Barangay Uling, City of Naga, Cebu for use in various barangay activities, community events, emergency response and other barangay related operations;

WHEREAS, the procurement of 22 tents, one (1) of each purok, will serve as a valuable resource for community gatherings, disaster preparedness, and other barangay-related functions, thereby strengthening community support and resilience;

WHEREAS, this Sanggunian deemed the request appropriate for funding allocation so as to support the successful operations and management of puroks in the said barangay.

NOW THEREFORE, on motion of Hon. Scott Juvenal A. Chiong, seconded by Hon. Letecia F. Abangan, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to approve the supply and delivery of movable tents to puroks of Barangay Uling for use during various barangay activities, community events, emergency response and other barangay related operations chargeable against lump sum appropriation specifically Gen. Fund 2025 - Subsidy to LGU\'s Aid to Barangays (Office of the City Mayor) in the amount of Five Hundred Fifty Thousand Pesos (₱550,000.00).
