**RESOLUTION NO. 2039-2025** 

APPROVING THE SUPPLY, DELIVERY AND INSTALLATION OF ONE (1)-UNIT CEILING-TYPE INDUSTRIAL FAN (14 INCHES) FOR THE COVERED COURT OF BARANGAY INOBURAN, CITY OF NAGA, CEBU CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF THREE HUNDRED THOUSAND PESOS (₱300,000.00)

WHEREAS, Ms. Gineveve V. Laput, City General Services Officer (CGSO), formally requested this Sanggunian for the passage of a resolution approving the grant and use of funds for the supply, delivery and installation of one (1)-unit ceiling-type industrial fan for the covered court of Barangay Inoburan, City of Naga, Cebu;

WHEREAS, this ceiling type industrial fan will be installed inside the covered court of Barangay Inoburan to improve air circulation and enhance comfort during various barangay activities such as meetings, gatherings, sporting events, emergency uses and others;

WHEREAS, this August Body finds it proper to approve the request for funding allocation of ₱300,000.00 so as to provide financial assistance and support for the proper management of the covered court of Barangay Inoburan.

Fund 2025 -Subsidy to LGU\'s Aid to Barangays (Office of the City Mayor) in the amount of Three Hundred Thousand Pesos (₱300,000.00).
