**APPROVING THE ALLOCATION OF FUND FOR THE PROCUREMENT OF ONE (1) UNIT UTILITY VAN AND ONE (1) UNIT MOTORCYCLE CHARGEABLE AGAINST LUMP SUM APPROPRIATION UNDER THE GENERAL FUND TOTALING ONE MILLION TWO HUNDRED SEVENTY-SIX THOUSAND THREE HUNDRED SIXTY PESOS (P1,276,360.00)**

**WHEREAS**, Republic Act (RA) No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units (LGU) shall, among others, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, subjected to deliberation is the request of the City General Services Office (CGSO) for the allocation of fund to acquire motor vehicles for official use of this LGU, with details specified as follows:
