## RESOLUTION NO. 2047-2025

APPROVING THE PROVISION OF MEALS AND SNACKS DURING THE SENIOR CITIZENS SOCIAL PENSION PAY-OUT FOR THE 2<sup>ND</sup> QUARTER 2025 CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF FORTY-FIVE THOUSAND ONE **HUNDRED PESOS (₱45,100.00)** 

WHEREAS, the Social Pension for Indigent Senior Citizens is the provision of monthly pension to qualified indigent senior citizens in the amount of One Thousand Pesos (₱1,000.00) as government assistance, stipulated under Republic Act 9994 otherwise known as "The Expanded Senior Citizens Act 2010";

WHEREAS, the City Social Welfare and Development (CSDO) requested this Sanggunian for approval of funds granting the amount of ₱41,100.00 for the provision of meals and snacks for the holding of the Senior Citizens Social Pension Pay-out for the 2<sup>nd</sup> Quarter of 2025 to 2,256 identified social pensioners in the City on May 29 - 30, 2025;

WHEREAS, attached to the request is a copy of a Commission on Election (COMELEC) Memorandum No. 25-06850 dated April 27, 2025 exempting the Social Pension pay out for indigent senior citizens from the provisions of Section 261 (V) of the Omnibus Election in relation to COMELEC Resolution No. 11060, as amended in view of the conduct of the May 12, 2025 National and Local Elections.

WHEREAS, the August Body, in a session duly assembled, recognized that necessity of this monetary grant to augment the daily subsistence and other medical needs of the elderly citizens in the City of Naga, Cebu.

NOW THEREFORE, on motion of Hon. Letecia F. Abangan, seconded by Hon. Charmaine R. Navarro, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to approve the provision of meals and snacks for the Senior Citizens Social Pension Pay-Out for the 2<sup>nd</sup> Quarter 2025 chargeable against lump sum appropriation specifically General Fund - Office of the City Mayor - Other Maintenance and Operating Expenses in the amount of Forty-Five Thousand One Hundred Pesos (₱45,100.00).
