AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A MEMORANDUM OF AGREEMENT (MOA) WITH KEPCO SPC POWER CORPORATION FOR THE LATTER'S COMMITMENT TO SUPPORT THE OPERATIONS OF VICENTE MENDIOLA CENTER FOR HEALTH (VMCH) BY DONATING ONE MILLION THREE HUNDRED TWENTY THOUSAND PESOS (₱1,320,000.00) FROM ITS ANNUAL SOCIAL DEVELOPMENT MANAGEMENT PROGRAM (SDMP) OR CORPORATE SOCIAL RESPONSIBILITY (CSR) FUNDS

WHEREAS, the VMCH has been operating since 2018 as the City Government's one-stop health care facility to provide quality, accessible yet affordable health care services to its constituents especially to the less privileged Nagahanons;

WHEREAS, KEPCO SPC Power Corporation, a power generation company in Barangay Colon, City of Naga, Cebu, expresses its commitment to support the City Government's healthcare initiatives, specifically the operations of VMCH by donating One Million Three Hundred Twenty Thousand Pesos (₱1,320,000.00) from its SDMP or CSR funds, through the City Government;

WHEREAS, the City Government recognizes KEPCO SPC's genuine commitment and expresses gratitude and appreciation for the latter's unwavering support, kindness and liberality;




