RESOLUTION NO. 2051-2025

GRANTING MS. GENELYN ABATAYO AND MR. REYNALDO O. CABURNAY SPECIAL PERMITS FOR THE CONDUCT OF HACKFIGHTS AND THREE-COCK DERBY AT ULING COCKPIT IN BARANGAY ULING AND NAGA SPORTS ARENA IN BARANGAY SOUTH POBLACION, CITY OF NAGA, CEBU, RESPECTIVELY, ON MAY 28, 2025 AND FOR THE MONTH OF JUNE 2025 PURSUANT TO CITY ORDINANCE NO. 2024-41 AS AMENDED

WHEREAS, City Ordinance No. 2024-41, as amended, governs the establishment, operation and maintenance of cockpits and regulates cockfighting and imposes fees in the City of Naga, Cebu;

WHEREAS, Section 4 (a) of the Ordinance explicitly provides that regular cockfighting shall be held only on Sundays, legal holidays and local fiestas for not more than three (3) days, and requires franchisees to secure permits for the conduct of cockfights to be held not on the aforesaid regular schedule;

WHEREAS, Ms. Genelyn Abatayo, owner of Uling Cockpit in Barangay Uling, City of Naga, Cebu and Mr. Reynaldo O. Caburnay, cockpit operator of Naga Sports Arena in Brangay South Poblacion, City of Naga, Cebu formally requested in separate letters to the Office of the City Mayor that they be granted special permits to hold hackfights and three-cock derby on May 28, 2025 and for the month of June 2025, specified hereunder as follows:



Caburnay special permits for the conduct of hackfights and three-cock derby at Uling Cockpit in Barangay Uling and Naga Sports Arena in Barangay South Poblacion, City of Naga, Cebu, respectively, on May 28, 2025 and for the month of June 2025 pursuant to City Ordinance No. 2024-41 as amended.


