FAVORABLY ENDORSING TO THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) THE CONSTRUCTION OF MARITIME POLICE REGIONAL HEADQUARTERS (VISAYAS) IN THE CITY OF NAGA, CEBU AND CONFIRMING THAT UPON TURNOVER, THE CITY GOVERNMENT ACCEPTS THE RESPONSIBILITY FOR THE MAINTENANCE OF THE INFRASTRUCTURE AS MANDATED BY REPUBLIC ACT 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, the Philippine National Police (PNP)-Regional Maritime Unit 7 has decided to relocate its Visayas Regional Headquarters in the City of Naga, particularly in Barangay Tina-an adjacent to the PNP City of Naga, Cebu Station;

WHEREAS, the Office of the City Mayor received a formal letter from Engr. Danilo J. Villa, Jr., DPWH Regional Director, requesting the endorsement of the above-stated project through a resolution issued by the Sangguniang Panlungsod as part of the documentary requirements for the release of funds;

WHEREAS, the City Government of Naga, Cebu respectfully endorses to the DPWH the construction of Maritime Police Regional Headquarters (Visayas) in the city, with details specified hereunder, to wit:
