APPROVING THE COST OF LABOR AND MATERIALS FOR THE INSTALLATION OF THREE (3)-UNITS LAMPPOST WITH CONCRETE PEDESTAL AT THE NEWLY CONCRETED ROAD IN BARANGAY TINAAN (3 POSTS), CITY OF NAGA, CEBU CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF FORTY-NINE THOUSAND SIX HUNDRED SEVENTY-TWO PESOS (₱49,672.00)

WHEREAS, the Office of the City Engineer has requested this Sanggunian for approval of the use of funds for the procurement of materials such as six (6) meter deformed bar, GI pipe sched, reducer, welding rod, cutting disk, washed sand, gravel, tie wire, including the cost of labor for foreman, skilled and unskilled laborer for the above-stated project in the total amount of ₱49,672.00;

WHEREAS, this August Body, in a session duly assembled, deemed the request justifiable for funding allocation after it ascertained the availability of funds for the implementation of the project pursuant to the developmental plans and programs of this administration.

RESOLVED, as it is hereby RESOLVED, to approve the cost of labor and materials for the installation of three (3)-units lamppost with concrete pedestal at the newly concreted road in Barangay Tinaan (3 posts), City of Naga, Cebu chargeable against lump sum appropriation specifically General Fund 2025 - Other Structures (Office of the City Mayor) in the amount of Forty-Nine Thousand Six Hundred Seventy-Two Pesos (₱49,672.00).
