INTERPOSING NO OBJECTION TO THE PROPOSED SERVICE PLAN FOR A NEW MODERN PUBLIC UTILITY VEHICLE (PUV) ROUTE CONNECTING THE CITY OF NAGA TO IT PARK, CEBU CITY AND VICE VERSA AND FAVORABLY ENDORSING THE INCLUSION OF THE NAGA-IT PARK-NAGA ROUTE IN THE MODERN PUV SERVICE PLAN

WHEREAS, the Office of the City Mayor received a formal letter request from COC Fleet Transportation OPC, a duly registered and accredited transport service provider, regarding its proposed service plan for a new PUV route connecting the City of Naga to IT Park, Cebu City and vice versa;

WHEREAS, the Honorable City Mayor Valdemar M. Chiong expresses no objection to the aforementioned proposal and endorses the same to the Office of the Sangguniang Panlungsod (SP) as the SP endorsement will facilitate coordination with the Land Transportation Franchising and Regulatory Board (LTFRB) Region VII and other concerned agencies for the necessary approval and other pertinent documents;

WHEREAS, finding merit on the proposal, the SP finds the proposed service plan for a new PUV route vital in improving the efficiency, safety and reliability of public transportation system especially for the daily commuters.
