AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN THE DEED OF DONATION AND OTHER RELATED DOCUMENTS THEREOF, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, FORMALLY ACCEPTING ONE (1) UNIT OF PATIENT TRANSPORT VEHICLE (PTV) FROM THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO)

WHEREAS, the City Government of Naga, with its thrust of delivering quality health services to its constituents, is among the potential beneficiaries of one (1) unit of PTV from PCSO that will augment the existing ambulance vehicles in transporting patients to hospitals and other treatment facilities;

WHEREAS, the PCSO, a leading government agency for raising and providing funds for charities of national character, is donating one unit of PTV to the City Government for use during emergency situations in order to optimize the latter's public health care program;

WHEREAS, this Sanggunian, in a session duly assembled, deemed it appropriate to support the call of the Office of the City Mayor for assistance from the PCSO through the latter's donation of one unit emergency vehicle to this local government unit.

NOW THEREFORE, on motion of Hon. Carmelino N. Cruz, Jr., seconded by Hon. Letecia F. Abangan, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign the Deed of Donation and other related documents thereof, for and in behalf of the City Government of Naga, Cebu, formally accepting one (1) unit of PTV from the PCSO.
