AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A CONTRACT OF AGREEMENT WITH ISC ENGINEERING SERVICES FOR THE PROPOSED INSTALLATION OF STREET LIGHTS IN BARANGAY CABUNGAHAN, CITY OF NAGA, CEBU IN THE AMOUNT OF FOUR HUNDRED NINETY-SEVEN THOUSAND SEVEN HUNDRED THREE PESOS AND 94/100 (₱497,703.94)

WHEREAS, the City Government of Naga, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) the Request for Quotation for the project: "Supply of labor, materials and tools for the proposed installation of street lights in Barangay Cabungahan, City of Naga, Cebu;"

WHEREAS, in the Abstract of Quotation dated May 13, 2025, ISC Engineering Services, represented by its authorized representative Mr. Ignacio S. Ciloy, Jr., has submitted its bid price in the amount of ₱497,703.94 and was found to be the lowest calculated and responsive price quotation for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and ISC Engineering Services, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Contract of Agreement with ISC Engineering Services for the proposed installation of street lights in Barangay Cabungahan, City of Naga, Cebu in the amount of Four Hundred Ninety-Seven Thousand Seven Hundred Three Pesos and 94/100 (₱497,703.94).
