APPROVING THE PROPOSED CONSTRUCTION OF HOUSING UNITS SUBDIVISION AT PUROK TAPON 3, BARANGAY TINAAN, CITY OF NAGA, CEBU TO COVER THE VARIATION ORDER FOR THE INSTALLATION OF ELECTRICAL POWER SYSTEM AND EXTRA WORKS CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF THREE MILLION THREE HUNDRED THIRTY-SIX THOUSAND FIVE HUNDRED FIFTY-SIX PESOS AND 14/100 (₱3,336,556.14)
