RESOLUTION NO. 2074-2025

GRANTING FINANCIAL ASSISTANCE TO BARANGAY CENTRAL POBLACION, CITY OF NAGA, CEBU IN THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (₱800,000.00) FROM THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG UNDER THE AID TO VARIOUS BARANGAYS 2025 TO BE USED FOR THE PURCHASE OF A NEW VEHICLE TO SUPPORT BARANGAY OPERATIONS AND APPROVING THE TRANSFER OF THE AFOREMENTIONED AMOUNT TO THE BARANGAY ACCOUNT

WHEREAS, the barangay is the chief implementer of various programs in the grassroots level and acknowledges the importance of having strong partners in local governance;

WHEREAS, the Sangguniang Barangay of Central Poblacion passed Resolution No. 11, series of 2025 requesting financial assistance through the Office of the City Mayor in the amount of \$800,000.00 to be used for the purchase of a new vehicle to support barangay operations;

WHEREAS, the Barangay Council of Central Poblacion, during its regular session on January 03, 2025, deemed the necessity of the above-mentioned vehicle to enhance the mobility and efficiency of barangay officials and staff in the performance of their duties and in delivering services to the community;

WHEREAS, as indicated in the same resolution, the Barangay further requested that the financial assistance amounting \$\P\$800,000.00 be transferred to the barangay account for the implementation of the above-stated project.

WHEREAS, this Sanggunian deems it appropriate to approve the request, as the barangay project is in line with the development and infrastructure programs of the present administration.

NOW THEREFORE, on motion of Hon. Letecia F. Abangan, seconded by Hon. Scott Juvenal A. Chiong, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to grant financial assistance to Barangay Central Poblacion, City of Naga, Cebu in the amount of Eight Hundred Thousand Pesos (₱800,000.00) from the Honorable City Mayor Valdemar M. Chiong under the Aid to Various Barangays 2025 to be used for the purchase of a new vehicle to support barangay operations and approving the transfer of the aforementioned amount to the barangay account.
