WHEREAS, "Duwa ug Dasig: The 2025 Cebu Inter-Court Sportsfest" marks the first province-wide gathering of judges and court personnel from across Cebu for a unified sports event, which is designed to promote wellness, build camaraderie, and strengthen the sense of community within the judiciary through friendly competition and shared experiences;

WHEREAS, this August Body deemed it necessary to grant the request for funding allocation of the aforesated amount for the successful holding of the above-stated sportsfest which will be conducted on June 10-11, 2025.
