APPROVING THE CLOSURE OF LOCAL GOVERNMENT UNIT (LGU) SPECIAL SAVINGS DEPOSIT (SSD) ACCOUNT UNDER THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP)-TALISAY CEBU BRANCH

WHEREAS, Section 311 of RA 7160, otherwise known as the Local Government Code of 1991, provides that "Local treasurers shall maintain depository accounts in the name of their respective local government units with banks, preferably government-owned, located in or nearest to their respective areas of jurisdiction;"

WHEREAS, subjected to deliberation is the request of City Treasurer Trina L. Litorja for approval of the closure LGU SSD account under the DBP, with details specified hereunder, viz:
