RESOLUTION NO. 2081-2025

APPROVING THE CHANGE IN FUNDING SOURCE FROM TRUST FUND TO GENERAL FUND - CAPITAL OUTLAY FOR THE IMPLEMENTATION OF THE PROJECT "PROCUREMENT OF UPGRADED SWINE AND NATIVE PIG", A KEY IMPLEMENTATION UNDER THE SUGBO BABOYAN SA LIMPYO UG HAPSAY NGA TUGKARAN PROGRAM IN THE AMOUNT OF ONE HUNDRED TWENTY-ONE THOUSAND PESOS (₱121,000.00)

WHEREAS, the City Government is implementing the "Sugbo Baboyan sa Limpyo ug Hapsay nga Tugkaran", a program of the Cebu Provincial Government aimed at promoting organic and sustainable hog farming in Cebu;

WHEREAS, the City Agriculture Office successfully procured the following livestock from Pangdan Multipurpose Cooperative and underwent inspection and acceptance procedures on July 17, 2025 in the total amount of ₱121,000.00, with details specified hereunder, viz:

- Three (3) heads of native pig (black, newly weaned) 2 females and 1 male
- Five (5) heads of upgraded swine (newly weaned) all female
- Five (5) heads of swine (gilt) all female

WHEREAS, as stated in its letter-request dated May 30, 2025, the budget for the project was originally intended to be downloaded from the Cebu Provincial Government to the City Government of Naga under the Trust Fund account however, due to unforeseen circumstances affecting the release and transfer of funds, the Capital Outlay under the General Fund is proposed as the alternative funding source to ensure the smooth execution of this program;

NOW THEREFORE, on motion of Hon. Justino L. Dakay, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to approve the change in funding source from Trust Fund to General Fund - Capital Outlay for the implementation of the project "Procurement of Upgraded Swine and Native Pig", a key implementation under the Sugbo Baboyan sa Limpyo ug Hapsay nga Tugkaran Program in the amount of One Hundred Twenty-One Thousand Pesos (₱121,000.00).
