RESOLUTION NO. 2088-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A SERVICE AGREEMENT WITH CORE STRATEGIES TRAINING CONSULTANCY SERVICES FOR THE CONDUCT OF WORK ATTITUDE AND VALUES ENHANCEMENT (WAVE) TRAINING FOR VICENTE MENDIOLA CENTER FOR HEALTH (VMCH) INFIRMARY MEDICAL AND NON-MEDICAL STAFF

WHEREAS, the VMCH Infirmary recognizes the need to conduct the WAVE training to cultivate positive work behaviors, strengthen moral and ethical standards and promote professionalism among its workforce;

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), posted on Philippine Government Procurement System (PhilGEPS) a Request for Quotation for the procurement of a training service provider for the conduct of WAVE seminar both for medical and non-medical staff of VMCH Infirmary;

WHEREAS, CORE, a training service provider with business address in Poog, Toledo City, Cebu, responded to the PhilGEPS posting and submitted a quotation amounting to Two Hundred Fourteen Thousand Pesos (₱214,000.00) which the BAC found to be the lowest calculated and responsive quotation;

WHEREAS, the August Body, in a session duly assembled, found it justifiable to accept the offer of CORE to undertake the WAVE training in accordance with the Term of Reference set forth in the Service Contract.

NOW THEREFORE, on motion of Hon. Letecia F. Abangan, seconded by Hon. Justino L. Dakay, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Service Agreement with CORE Strategies Training Consultancy Services for the conduct of WAVE training for VMCH Infirmary medical and non-medical staff.
